VILAMOURA - ALGARVE

Em 1996 André Jordan parte para um novo desafio: recuperar a qualidade e grandeza de Vilamoura, tarefa que, atendo à dimensão do empreendimento e ao estado degradado exigia todos os recursos da sua experiência e visão no negócio imobiliário.

A recuperação da parte existente do resort, a elaboração e aprovação do Projecto Vilamoura XXI, a construção de novos campos de golfe e a reabilitação dos antigos fizeram da nova Vilamoura um case study internacional.

Em Vilamoura o André Jordan Group desenvolveu o The Residences at Victoria Clube de Golfe, um empreendimento de excelência composto por 145 apartamentos no coração de Vilamoura XXI.

In 1996 André Jordan set out on a new challenge: to recover the quality and grandeur of Vilamoura, a task that, taking into account the size of the resort and the degraded state of it, required all the resources, experience and vision the group had.

The recovery of the old part of the resort, the preparation and development of the Vilamoura XXI Project, the construction of new golf courses and the rehabilitation of the old ones made the new Vilamoura an international case study.

In Vilamoura the André Jordan Group developed The Residences at Victoria Clube de Golfe, an admirable development consisting of 145 apartments in the heart of Vilamoura XXI.



BELAS CLUBE DE CAMPO - BELAS, SINTRA

O Belas Clube de Campo é uma comunidade residencial com 800 famílias, um championship golf course, a 15 minutos do centro de Lisboa, numa propriedade onde se conjugam áreas residenciais e de lazer em harmonia com a natureza envolvente, resultado da visão e experiência do André Jordan Group.

Um amplo leque de serviços e infraestruturas estão disponíveis aos residentes, tais como Centro Desportivo com Health Club & Day Spa, Café, Mini Mercado, ténis, futebol, playgrounds e vigilância 24 horas por dia.

Apresentando o mais baixo índice de densidade populacional na Grande Lisboa, o projeto integra o Lisbon Green Valley oferece apartamentos, townhouses e lotes para moradias sendo considerado o novo destino de Lisboa.

Belas Clube de Campo is a residential community with presently 800 families, a championship golf course, 15 minutes from Lisbon center, in a property where residential and leisure areas are combined in a harmonious way, result of André Jordan Group's vision and experience.

Residents benefit from a wide range of services and common facilities such as a Sports Center with Health Club & Day Spa, Coffee Shop, Convenience Store, tennis, football, playgrounds and an internal security system which operates 24 hours a day.

Presenting the lowest population density in Greater Lisbon residential area, the project integrates the Lisbon Green Valley, currently under development and commercialization with apartments, townhouses and plots for houses being considered Lisbon's new destination.
